
BHS Selected for OSU Chinese Flagship Program

Beachwood High School is one of three schools in Ohio selected to participate in The Ohio State University K-12 Chinese Flagship Program.

The Flagship Program offers support in curriculum development, teacher training and technology support for its partner schools. The program also facilitates connections to qualified schools and education facilities in China for joint programming, student exchange and immersion study trips.

The goal of the program is to provide the means by which Ohio students can become creative global citizens and operate effectively in both Chinese and American cultures. Beachwood High School offers classes in Chinese I, II and III, taught by **Chi-Hwa Yang**, with Exploratory Chinese, Chinese A and Chinese B taught by **Shuling Tai** at the Middle School. Nearly 200 students are enrolled in these classes.

This past summer, Superintendent Richard Markwardt, Ph.D., and Assistant Superintendent Philip Wagner, Ph.D., toured educational facilities in China with the Office of Chinese Language Council International and The College Board. The trip introduced delegates to Chinese governmental and educational leaders and provided contacts and resources to promote the study of Chinese language in U.S. schools.

The past eight years have been some of the most meaningful that I have experienced in my lifetime. At the risk of sounding cliché, serving the Beachwood community as a School Board member was a superb way to give back to the school that gave so much to me (as a student), allowing me to fully express the loyalty and gratitude that I feel toward Beachwood.

As I retire from the Board, I leave with a sense of great accomplishment and a heightened sense of confidence regarding the future of our District. There are countless elements contributing to the excellence of Beachwood Schools but there are a few that serve as the foundation. For starters, the families in Beachwood value education. Our parents are deeply concerned about their children's education and in ongoing fashion, challenge the administrators, faculty and School Board to aggressively pursue new initiatives and raise the bar on our expectations of excellence. We continue to recruit and employ a uniquely talented core of teaching professionals and classified staff. Our building administrators are intelligent, enthusiastic and creative individuals focused intently on student achievement. Lastly, our Central Office administrators are deeply committed to meeting the needs of all our students and creating innovative ways to provide a strong, rich and expansive education for our children. Throughout my tenure, we have had times where morale was high in only certain buildings, but this is the first time since I have been on the Board where I have felt that all our Principals have their buildings functioning at high capacity, with high morale and with a genuine sense of "family."

I am looking forward to seeing the benefits that will result from the many improvements implemented by our current administration. It will be exciting for me to watch our pre-engineering program develop and prepare our students for their collegiate and post-collegiate educations in a way that has no current parallel. This program will almost certainly enhance the way our students encounter and process the relationships between mathematics and the physical sciences. It is my personal hope that this program serves as a prototype leading to the establishment of pre-med and pre-law tracks, as well as a track geared toward business and finance. Additionally, our increased commitment to Chinese and Asian studies will serve our students well as they prepare for their futures in a growing global economy.

Our dedication to the High School Advisory Program will continue to help our students develop their social awareness while they grow intellectually. This will go a long way toward their fulfillment of our mission statement "to develop intellectual entrepreneurs with a social conscience."

We have enacted a strict and comprehensive residency policy and with this heightened commitment,we will be able to ensure that our schools are educating only students who live in Beachwood.

I have found it a curious phenomenon that from time to time over the years, I have had individuals tell me that Beachwood Schools are great for the gifted students and for the students with special needs, but we may not reach the same level of excellence for the students in the "middle." Our general data does not support this claim; in fact, to the contrary, most of our students go on to college and graduate in successful fashion. In spite of this incongruity, we (the School Board) do not discount these comments when they are presented to us. That being said, we are currently exploring the possibility of creating an International Baccalaureate Program. This would be a far-reaching addition to our curriculum that will augment the education of many of the students in the so-called "middle." This program will be one that brings further success and great prestige to our schools by providing enrichment opportunities for students.

Finally, I look forward to renewed enthusiasm between the School and City officials. We have had a long and strong history of working cooperatively. I have complete confidence that through collaboration, we will develop novel and effective ways to keep Beachwood Schools at the forefront of education so that our City continues to be the finest community for residents and businesses alike.

It has been my profound honor and great pleasure to serve the residents of this great community. I will forever treasure the friendships and relationships I have established while serving on the School Board. Just as when I was a student walking the halls of Beachwood High School, I am still overcome by pride when someone asks me where I'm from and I tell them I am from BEACHWOOD! Treasurer's Column

The recent coverage of the inside millage issue has generated many excellent and thoughtful questions by our citizens. My staff and I welcome the opportunity to be of service to you and to make the difficult topic of school finance as easy to comprehend as possible. In light of these questions, many involving timing of revenue collections, I thought this column might be a good method to explain how the District carefully plans and controls its finances.

Every school district in the State of Ohio is required to submit a five-year forecast by Oct. 31 of each year. The forecast details anticipated spending and revenue levels for each of the five upcoming fiscal years. School districts in this state operate on a fiscal year beginning July 1 and ending June 30. The forecast not only delineates the "numbers" aspect of the District's planning cycle, but is augmented by written explanation of the assumptions that are used in the forecast. The forecast documents the best information available at the time of the forecast. Of course, over time as new information becomes available, these assumptions are modified and improved, and the forecast is amended to reflect the new information.

The forecast not only is used as a planning tool, but is used by the State of Ohio to prevent school districts from entering contracts for which they have no long term ability to pay without additional funds. A school district is not able to enter into any contract that extends beyond the district's demonstrated ability to pay for that contract. School districts may only enter and certify the funds for a contract that the district has the ability to pay with *current resources*. This prevents school districts from negotiating, for

example, union contracts, lease agreements or capital improvement commitments that it is not able to pay for according to stipulated terms.

Assumptions are an integral component of the five-year fore-cast. They assist the reader in understanding how the forecast was created. The assumptions also delineate information of which the District is aware, but which is not included in the fore-cast for financial reasons. A good example of this is the Chagrin Highlands property. While our District acknowledges the existence of this property and its

revenue generating potential, those revenues are not included in the forecast as the District has not yet derived any property taxes from that property. Another example is our District's tax exempt litigation of the Cleveland Clinic Family Health Center on Cedar Road. While the Tax Commissioner found in the District's favor in October 2004 by ruling that the facility is, in fact, a property subject to taxation, the Clinic immediately appealed that decision to the Ohio Board of Tax Appeals. While this issue is in its second stage of litigation, the Clinic has not paid its growing property tax liability (as is its right). So our District's financial forecast does not include those revenue dollars, but acknowledges that if we ultimately win the case, it would have a very positive effect on our

More than 1.4 million juniors in nearly 21,000 high schools entered the 53rd annual National Merit Scholarship Program by taking the 2006 Preliminary SAT/National Merit Scholarship Qualifying Test (PSAT/NMSQT), which served as an initial screen of program entrants. The nationwide pool of Semifinalists, which represents less than one percent of U.S. high school seniors, includes the highest scoring entrants in each state. These 16,000 scholastically talented high school seniors have an opportunity to continue in the competition for Merit Scholarship awards.

The National Achievement Scholarship Program was established in 1964 to honor academically promising black youth throughout the nation. Holly is one of 3,000 outstanding participants of more than 140,000 students who entered the 2008 National Achievement Program.

Superintendent **Richard Markwardt**, **Ph.D.**, offered congratulations to the students for their national honor. "We take great pride in congratulating these extremely talented 'scholastic champions' for their academic excellence and success," he said.

Beachwood Sponsors Educational Forum to Support Children with Cochlear Implants

The Northeast Ohio Consortium for Children with Cochlear Implants (NOCCCI) held its inaugural Educator Forum *Have a Great School Year with a Child with a Cochlear Implant in your Classroom!* at Beachwood Middle School.

NOCCCI is a groundbreaking organization composed of professionals from local implant centers, educational institutions, early intervention, private therapy practices and community response agencies with one common goal: To support children with cochlear implants through cooperation, communication and education.

The Educator's Forum, sponsored by NOCCCI, The Ohio School for the Deaf-Center for Outreach Services, and three cochlear implant manufacturers (Advanced Bionics Corporation, Cochlear Americas and MED-EL Corporation), provided a full day of continuing education for more than 140 attendees including teachers, speechlanguage pathologists, audiologists, intervention specialists, interpreters and administrators.

Presenters included **Dr. Mike Scott, Dr. Peter Weber** and **Dr. Don Goldberg** from The Cleveland Clinic Hearing Implant Program; **Dr. Jane Dunay**, Beachwood City Schools Consortium for the Hearing Impaired; **Lori Ausperk**, Mayfield

62 Students Thrive in Beachwood

The Beachwood Scholars Advisory Network provides support and mentoring for 62 African American students in grades four through eight.

Coordinated by fifth grade teacher **Jason Hill** at Hilltop Elementary School and at Beachwood Middle School, sixth grade teacher **Terri Nicole Singleton** and guidance counselor **Carol Grooms**, the program combines one-on-one mentoring with traditional classroom, cultural, recreational and academic components.

Assisting the program is a newly formed Scholars Parent Support Group, led by parents **Karyn Smith** and **Karen Sullins**, which assists with lesson preparation, speakers and feedback.

The Beachwood Scholars Advisory Network is an outgrowth of recommendations from the District's Differential Achievement Committee (DAC), founded in 2003 and spearheaded by BHS social studies teacher **Greg Deegan.**

Ms. Singleton explained, "As a member of the DAC, I had the opportunity to learn from the current research on race and achievement, study data collected from our own District, and most importantly, observe how other educators were responding to the differential achievement between students of color and white students. We studied the Shaker Heights MAC Scholars program, where advisors lent us their enthusiastic support and even traveled to Hilltop to share their hard-earned insights on how their program operates. We then developed and tailored our program to fit the specific needs of our students here in Beachwood."

A pilot Scholars Program for 26 fifth and sixth graders was launched last school year that included semimonthly meetings, speakers and a field trip. This year, the program has been expanded to five grade levels in two schools, with plans for further expansion to Beachwood High School in 2008-09.

"One of the things that makes our program unique is the one-on-one advisement piece," said Ms. Singleton. "In addition to meetings twice a month, each student in grades six through eight is assigned an advisor who assists him or her in setting goals and otherwise navigating the academic terrain of the school."

At these one-on-one sessions, Scholars learn SMART (Specific, Measurable, Attainable, Reasonable, Timely) goal setting; GPA and performance monitoring, and troubleshooting. The program uses the "Possible Selves" curriculum developed by Daphne Oyserman, Ph.D., from the University of Michigan to identify positive adult images and make connections between specific strategies, hard work in school and racial identity. Advisors provide support and encouragement to help students work toward their goals and complete their tasks.

"As our new guidance counselor, Ms. Grooms offers a skill set and resources which have tremendously strengthened the program," said Ms. Singleton. Teachers **Jill Goodman** and **Tucker White** act as adjunct advisors for the BMS students.



Scholars Program

At Hilltop, Scholars in grades four and five meet weekly in a study circle and tutoring session with Mr. Hill, with the goal of preparing students for the academic expectations of the Middle School and helping them meet Scholars criteria.

Students sign a commitment form that they will strive to achieve specific positive attitude and effort marks, dress in business attire for meetings, and attend and participate in group activities. At the end of the school year, they are inducted as Scholars if they achieve these goals.

Lessons taught at Scholars meetings have ranged from "author vs. victim" language and behavior, study skills, and conflict resolution. An open forum is always provided for students to voice their questions and concerns.

"The Beachwood Scholars program helps participants develop strong math, reading, oratorical and analytical thinking skills and the competencies needed to be involved, resilient and successful," said Mr. Hill.

"The program fosters a school-family-community bond," he continued. "Kids and families who feel comfortable and successful in school and feel like the school is responsive to their needs and interests will have a much brighter future than kids who don't have these connections.

"Our Scholars program provides an alternative environment that is in tune with African American students' interests, motivations and needs. The program provides opportunities for the kind of personal attention from adults that young people crave, a positive peer group, and activities that hold their interest and build their self-esteem.

"My students are amazing. I am privileged to serve as their teacher."

activities through The Diversity


Center, formerly the National

Bryden music teacher **Darlene Haight** received a PTO grant to support the Remo Sound Drums project and a "Roots of Rhythm" workshop, where children create drums while learning a multitude of drumming activities that will enhance their math, science and cultural awareness in preparation for a "Stomp" Concert.

Instant Access to Your Children's Grades

Beachwood Middle and High School parents now have real-time access to their children's grades in every class.



The eSIS Parent Assist Module (PAM) allows parents to log in using a password to see their children's cumulative grades for the present quarter, grades received on each individual assignment, final quarter grades after each marking period is complete, and daily attendance. If a teacher posts assignments in advance of grading them, parents also can view what lies ahead and the respective due dates.

Parents of Hilltop students have access to daily attendance and class schedules. Parents of Bryden students have access to daily attendance.

Parents who have multiple children enrolled in the Beachwood Schools can use their usernames and passwords to access information about each of their children.



throughout the year, both in season and out of season


and on and off the field."

financial position and the timing of any future levies. Currently, the Clinic is in arrears \$3.5 million for this property, inclusive of interest and penalties. The District does not expect the present litigation to be decided until the first or second quarter of 2009 at the earliest.

One of the challenges in preparing a five-year forecast is that the schools operate on a fiscal year, but property taxes are collected on a calendar year. Property taxes are the main source of revenue for the schools. So while the fiscal year for the schools begins July 1, the tax year does not commence until the following January. While the five-year forecast is actually adopted in October of each year, planning actually begins the prior January with the District's submission of its tax budget.

The District is very strategic and comprehensive in its approach to anticipating trends, financial challenges, levy timing,

enrollment and expenditure patterns in developing our financial forecasts and budgets. Our plan is forward-thinking and involves input from the Board and Administration. While the five-year forecast only delineates anticipated spending and revenue levels for the General Fund (which pays the day-to-day operating costs of the District), our schools also plan and study capital needs over a five-year period.

Capital needs are "bricks and mortar" type of expenditures. As with many of you who own homes, the schools also have ongoing costs of maintaining and improving our property. We anticipate boiler repairs, roof repairs, new equipment needs, vehicle purchases (buses, maintenance vans used in snow removal, etc.), land-scaping and field improvements, as well as major overhauls or building additions, to name just a few. The five-year capital plan

is updated at least on an annual basis. It becomes a tool to schedule projects and to earmark sources of funds for these projects. It also provides the District and staff a blueprint on the timing of projects and when major projects are anticipated to be completed.

The District is constantly changing and revising our financial plans as new and sometimes unanticipated events occur (for instance, if we have to add an additional teacher(s) due to increased enrollment, if a boiler shuts down and needs emergency repairs, or if trends in delivering quality education necessitate building reconfigurations). It is a process that involves a great deal of time, expertise and input from many stakeholders. Our District is strategic and forward-thinking in its planning, with the center of focus always on our students and their needs.

Beachwood Middle School Named One of Two "Ohio Schools to Watch"

Beachwood Middle School is one of two middle schools in Ohio honored by the National Forum to Accelerate Middle-Grades Reform, in cooperation with the Ohio Department of Education, as a "School to Watch."
